Open Play at the Community Recreation Center Gym:

We will need to set up the net on Fridays for open gym volleyball.

Friday, November 10, 2006 and Friday, November 17, 2006 will be the first two evenings of open play. These two evenings will be free. After that, the fee will be \$2/person. We will play from 7:00 PM to 9:00 PM.

Great Falls Park and Recreation Indoor Volleyball Tournament:

Rebecca would like the Park and Recreation to host an indoor volleyball tournament open to all local and in-state teams. The tournament will take place Saturday, March 31, 2007. Rebecca will check with the GFPS to see if the Great Falls High School Fieldhouse and Old Gym are available.

The tournament will be coed 6's (one alternate) with a minimum of 8 teams and a maximum of 16 teams. The fee will probably be \$100/team. Cash prizes will be awarded the top teams.

Rebecca would like to sell T-shirts at the tournament and will check into sponsorships for the tournament. She'll also check into room rates from hotels for out-of-town teams.

Rebecca will create the tournament flyer and registration forms, so Krista can email the information to her MT volleyball contacts. Hopefully, we'll have a good turn-out.

Krista will email Rebecca the flyer that the Casper, WY Park and Recreation department had for their 21st annual volleyball tournament this fall.

The three attending this meeting will be thinking of a good name for the tournament.
